Final Notes on eLitigation Launch (Supreme Court Phase) Launch Date: 2 January 2013

Please find below key information to take note of prior to commencing filings for Supreme Court via eLitigation from 2 January 2013. Please circulate a copy to all lawyers and users of eLitigation in your firm.

1) eLitigation Practice Reference Guide
