Update on eLitigation Preview Three exercise (19 August to 30 August 2013)

Thank you for participating in the Preview Three exercise.

We would like to update you that in response to feedback received, the scope of the Preview Three exercise has been expanded to include more cases at the Subordinate Courts. Your list of cases will now include cases as at 31 May 2013 in which a document (except a request for file inspection, certified true copy or soft copy) was filed or a hearing was conducted during the period from 1 March to 31 May 2013.

The **objective** is to ensure that all firms have hassle-free access to a wider range of recent and active cases (whether pending or administratively concluded) when the eLitigation phases for the Subordinate Courts are launched.

You will be able to view your updated list of cases starting **Monday 26 August 2013** when you open the "Preview Three" tab. For easier identification, cases which have been newly added to the Preview Three exercise will be indicated with a star icon, as shown in the screen capture below.
