# Update Letter: LawNet Due Diligence service will be replaced by eLitigation Cause Book Search (CBS) Service from 15 October 2013

Thank you for your kind support for the LawNet Due Diligence service.

Please be reminded that the Due Diligence module will be replaced by a new enhanced integrated search module for litigation data named Cause Book Search with effect from 15 October 2013. The LawNet Due Diligence service will be decommissioned on the same day.

Please take note of the following to facilitate smooth transition to CBS platform in eLitigation on 15 October 2013.

## Updated CBS Fee Structure

Please take note that updated fees are applicable for information searches conducted in CBS. The fee structure is intended to provide a more comprehensive search across related areas for one flat fee, differentiated by the Court searched. Users will find it more cost effective and efficient as all relevant results responding to the search parameters will be made available as part of the flat fee. There will no longer be any need to carry out composite searches followed by specific searches.

In addition, the fee for bankruptcy searches will be \$6 for subscribers and \$9 for non-subscribers per year, not \$25 and \$30 as described earlier.

Please refer to Annex A in this letter for a list of updated search fees.

Information services providers who conduct CBS searches in bulk may apply for a partial waiver of the collection of CBS search fees. Please contact the eLitigation Change Management Team for more details.

## Searches in Purchase Log:

The searches stored in your Due Diligence Purchase Log will not be available from 15 October 2013. Users are advised to download and save their searches before then.

### Access to ACRA data

If your subscription plan currently provides access to ACRA-related information in the Due Diligence module in LawNet, you can continue to use your existing ID to access the same type of information such as Instant Company and Business/ LLP and people profile searches via BizNet-Global (<u>https://www.biznet-global.com</u>), a proprietary service owned by Crimsonlogic.
